### CATEGORIES AND CONDITIONS OF MEMBERSHIP

1. Junior members under 18 must have at least one parent join as an Associate Member.
2. Members are expected to attend working bees throughout the year. Members that choose not to work at least 8 hours per-quarter (as per the By-Laws and in the case of agistees, 16 hours), may either pay the upfront levy for the year, or pay \$160.00 for each unattended quarter throughout the year.
3. The FTP grounds are kept locked at all times. Financial members can obtain a gate key by paying the \$25 deposit and signing the gate key declaration.
4. Regardless of any paid working bee exemption, ALL members must contribute 2 hours of assistance at each competition held throughout the year.
5. In all other respects, the FTPEC by-laws and club regulations will apply to your membership and it is a condition of your membership that you comply with them and any other direction given to you by the FTPEC committee.

6. By signing this form, you acknowledge that you understand that horses are unpredictable and horse sport events can be a dangerous sport. While all reasonable endeavours are taken to ensure the grounds are safe for use for their intended purpose, you acknowledge and agree that it is reasonably expected you and/or your horse may incur an injury (or injuries) when engaging with horses on the grounds. To the greatest extent possible by law, by signing this form, you:

## **IMPORTANT NOTICE ACCOMPANYING MEMBERSHIP FORM**

1. For the 2019 year, the FTPEC Committee has announced that the period of membership is from 1 March 2019 to 28 February 2020. This means:
  - a. current members will remain members until 28 February 2020 and do not have to renew their membership until 28 February 2020 (although you may at any time complete your membership forms and pay the membership form before that time). You simply need to ensure that during the period 1 January to 28 January 2020, you maintain your EA membership;
  - b. new members may complete and return this membership form and pay the membership fee and have the benefit of membership to 28 February 2020.
2. The by-laws were amended at the end of 2017. The by-laws may be amended from time to time and any such amendment will be announced to all members and will apply with immediate effect. Please ensure that you have read and understood the terms of the by-laws as they will be strictly enforced against all members.
