IMPORTANT – PLEASE NOTE:

- 1. Working Bee hour commitments are calculated on a per family basis, except for Agistees which are calculated on a per horse basis.
- 2. Working Bee hour commitments which are not met are calculated in accordance with 5 below **except** Agistee members. Given the importance of Agistee members' contribution to the maintenance of the grounds, **Agistee Members are not permitted to pay out Working Bee hours.**
- 3. "All family Riding Members must be from the same Riding Membership category. That is, all riders in the family fall under the "Full Member" category, or all riders in the family fall under the "Dressage Member" category.
- 4. An Associate member is required for at least one adult member of a family where the riding member is under 18 years of age. Associate members are not required to be EA registered.
- 5. We would like to advise that in calculating our membership fees for the 'Can't Help' and 'Half a Help' membership categories, we have adopted a working bee hourly rate of \$25 per hour (previously \$18.13 per hour). Any unworked quarterly hours for the 'Happy Helper' membership category, will be invoiced quarterly at \$30 per hour. We hope that the members can appreciate that it is almost impossible to replace unworked hours with outside contractor time at these rates.
- 6. The Dressage Riding Member is only available as a 'Happy Helper' membership, subject to any unworked quarterly hours being invoiced at \$30 per hour.
- 7. In order to maintain the condition of the Club's arena surface, all temporary show jump structures are to be moved on a regular basis, take off and landing spots are to be raked after use and a fully erected dressage arena is only in place for competitions, clinics and protocol days.
